TERMS AND CONDITIONS

PROMOTOR

1. The Promoter is ISPT Pty Ltd (ABN 28 004 582 423) (**Promoter**) of Level 11, 8 Exhibition Street, Melbourne, VIC, 3000.

INTRODUCTION

- 2. Information on how to enter and the prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
- 3. To the extent of any inconsistency between these Terms and Conditions and any other reference to this promotion, these Terms and Conditions prevail.

WHO CAN ENTER?

- 4. Entry is only open to Western Australian residents aged 18 years and over. Any entrant who does not reside in Western Australia with a valid residential address will not be deemed an Eligible entrant and is not eligible to participate in this promotion.
- 5. Employees (and their immediate families) of the Promoter, Participating Centre (defined below), Participating Retailer (defined below) and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.

PROMOTIONAL PERIOD

- 6. Entries into the promotion open on 30/06/2025 and close at 11:59pm AWST on 04/07/2025 ("**Promotional Period**").
- 7. Any entries received outside of the Promotional Period will be deemed invalid and will not be accepted. The Promoter does not accept any responsibility for delayed, incomplete or incorrect entries.

HOW TO ENTER

- 8. This promotion will be conducted at the following participating centre: Enex Shopping Centre (**Participating Centre**).
- 9. A **"Participating Retailer"** means any retailer at the Participating Centre. An **"Ineligible Transaction"** means any transaction recorded on an invalid receipt (as specified in Clause 13 below).
- 10. To be eligible to enter individuals must, during the Promotional Period, spend \$15 or more in one (1) transaction at the Participating Centre, excluding any Ineligible Transaction ("Qualifying Spend").

- 22. As a condition of accepting the Enex Pays-enabled Prepaid Gift Card, the Promoter reserves the right to request entrants to:
