

## ENEX X MJ BALE RUGBY GIVEAWAY

### TERMS AND CONDITIONS

1. Information on how to enter and the prize form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Entry is only open to Western Australian residents aged 18 years and over who are able to attend the 2025 Bledisloe Cup taking place on 04/10/2025 at Optus Stadium, Perth. Any entrant who does not reside in Western Australia with a valid residential address will not be deemed an Eligible entrant and is not eligible to participate in this Promotion.
3. Employees (and their immediate families) of the Promoter, Participating Stores (defined below) and agencies associated with this promotion are ineligible to enter.
