"ENEX BLACK FRIDAY SPEND AND WIN"

TERMS AND CONDITIONS

- 1. Information on how to enter and the prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
- 2. To the extent of any inconsistency between these Terms and Conditions and any other reference to this promotion, these Terms and Conditions prevail.
- 3. Entry is only open to Western Australian residents aged 18 years and over. Any entrant who does not reside in Western Australia with a valid residential address will not be deemed an Eligible entrant and is not eligible to participate in this Promotion.
- 4. Employees (and their immediate families) of the Promoter, Participating Retailers (defined below) and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
- 5. A participating retailer is any retailer located at Enex Shopping Centre ("Participating Centre") during the Promotional Period ("Participating Retailer"). An "Ineligible Transaction" means any transaction recorded on an invalid receipt (as specified in Clause 10 below).
- 6. The promotion commences for purchases on 24/11/2025 and closes at 2:00pm AWST on 28/11/2025 or once 300 gelato cups have been claimed, whichever is first ("**Promotional Period**").
- 7. Any entries received outside of the Promotional Period will be deemed invalid and will not be accepted.
- 8. To be eligible to enter and receive a promotional gelato cup ("**Gelato Cup**"), while stocks of Gelato Cups last, individuals must during the Promotional Period undertake the following steps:
 - a) Visit the Participating Centre and make a purchase at a Participating Retailer excluding any Ineligible Transaction ("Qualifying Purchase"). In the event a purchase receipt is not automatically handed to the entrant at the time the Qualifying Purchase was completed, it is the entrant's responsibility to request one;
 - b) Present a valid receipt showing the Qualifying Purchase (which must specify the Participating Retailer and date/time of purchase) to the staff at the gelato cart at the Participating Centre between 9am and 2pm on 28/11/2025;

 - d) Upon completing the entry form, and while stocks of Gelato Cups last, individuals will be given a promotional Gelato Cup. Each Gelato Cup will contain a sticker. Individuals must peel their sticker to reveal if they have won an instant prize. Winners of an instant prize can return their winning sticker to the concierge staff of the Participating Centre in order to claim their prize. All prize claims must be received by 2:00pm AWST on 28/11/2025
- 9. Only one (1) entry is permitted per person during the Promotional Period.

- 10. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. Any unused balance of an Enex digital Gift Card or Retailer Voucher will not be awarded as cash. - 19. If any prize is unavailable, the Promoter, in its discretion, reserves the right to substitute the prize with a prize to the equal value or specification, subject to any written directions from a regulatory authority.
