

“ENEX INSTANT WIN ACTIVATION”

TERMS AND CONDITIONS

1. Information on how to enter and the prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Entry is only open to Western Australian residents aged 18 years and over. Any entrant who does not reside in Western Australia with a valid residential address will not be deemed an eligible entrant and is not eligible to participate in this Promotion.
3. Employees (and their immediate families) of the Promoter, Participating Stores (defined below) and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
4. A participating store is any retailer located at Enex Shopping Centre (excluding Woolworths Supermarket) during the Promotional Period (“**Participating Store**”). For clarity, purchases made from Woolworths Supermarket will not be deemed eligible for the purposes of this promotion.
5. The promotion commences on 29/04/2026 and concludes at 5:00pm AWST on 20/05/2026, or until scratch cards run out, whichever is first to occur (“**Promotional Period**”).
6. To be eligible to enter and receive a scratch card individuals must, in a single transaction, spend \$15 or more at a Participating Store during the Promotional Period and while stocks of scratch cards last (“**Qualifying Spend**”). In the event a scratch card is not automatically handed to the entrant at the time the Qualifying Spend was completed, it is the entrant’s responsibility to request one.
7. Entrants must then scratch their scratch card to reveal whether or not they have won an instant prize. To claim a prize, entrants must present (and surrender) their winning scratch card to the relevant Participating Store associated with the instant prize won, or where relevant a member of staff at Enex Shopping Centre. Instant win prize claims must be received by 5:00pm AWST on 3/06/2026. Instant winners will be required to provide their details in order to claim their prize. Winners and non-winners may also enter the major draw by scanning the QR code on the scratch card and completing the online entry form during the Promotional Period (i.e. by 5:00pm AWST on 20/05/2026) and prior to claiming an instant prize (where relevant).

Multiple entries permitted, subject to the following: (a) only one (1) scratch card is permitted per Qualifying Spend (regardless of the amount spent in that transaction in excess of \$15); (b) only one (1) entry into the major draw is permitted per scratch card; and (c) each entry must be submitted separately and in accordance with entry requirements.
9. Entrants must retain a copy of their original purchase receipt(s) for all entries as proof of purchase. Failure to produce the proof of purchase when requested may, in the absolute discretion of the Promoter, result in invalidation of ALL of an entrant’s entries and forfeiture of any right to a prize. Purchase receipt(s) must clearly specify the product purchased, store of purchase and that the purchase was made during the Promotional Period but prior to entry.
10. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant’s identity, age and place of residence) and reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached

any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the promotion. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.

11. Incomplete or indecipherable entries will be deemed invalid.
12. If there is a dispute as to the identity of an entrant, the Promoter reserves the right, in its sole discretion, to determine the identity of the entrant.

MAJOR DRAW

GENERAL
